## **VOYAGES** contest rules

The "**VOYAGES**" contest is organized by Les Constructions Groupe Mathieu Inc. (hereinafter referred to as "Groupe Mathieu"). This contest is administered by the Effet Boomerang agency (hereinafter referred to as the "contest administrator"). The competition runs from **November 28, 2022,** at 00:00:01 a.m. Eastern Standard Time, to **August 18, 2023**, at 11:59:59 p.m. Eastern Daylight Time (hereinafter referred to as the "Competition Period").

## ELIGIBILITY

This contest is exclusively offered to purchasers of those properties specifically mentioned in this paragraph and which are sold by Groupe Mathieu and/or one of its subsidiaries in the following five (5) projects, hereinafter referred to as "eligible projects":

- 1. The townhouses of the <u>Station 56 project;</u>
- 2. The condos of the Station 56 project;
- 3. The townhouses of the <u>Place Notre Dame project;</u>
- The townhouses of the <u>Noüvo District project;</u>
- 5. The luxury homes of the Le Prestige Chambéry project;

Those eligible to participate in the contest are purchasers of the eligible projects in their entirety during the competition period and are referred to hereinafter as "participants".

#### EXCLUSIONS

The contest excludes buyers of other Groupe Mathieu properties not included as eligible projects, employees, agents, representatives of the contest organizer and administrator, its subsidiaries, their advertising and promotional agencies, as well as immediate family members (brothers, sisters, children, father, mother), their spouses and all persons with whom they are domiciled.

#### HOW TO PARTICIPATE AND ENTRY LIMITS

#### Purchases required for participation, as specified in the ELIGIBILITY section

#### Participation

Throughout the contest, participants will be entered in a participant register by Groupe Mathieu. Each participant's first and last names, type of property acquired, property project, acquisition address, purchase date, telephone number and e-mail addresses will be listed. Each entry is assigned a unique entry number.

#### **Entry Limit**

There is a limit of one entry per property that is sold in eligible projects throughout the competition period.

#### **Chances of winning**

The odds of winning one of the prizes are a maximum of three (3) out of seventy (70), the number seventy (70)

being the number of properties that can be sold in these projects and during this period.

# Participation above the required limits

Participants must respect the participation limits stipulated in these rules, or the contest administrator may disqualify any participant who attempts to enter this contest by any means that violate these rules, or are of an unfair nature to other participants (e.g., number of entries exceeding the allowable limit, purchase of a Groupe Mathieu property not included in the list of eligible projects, use of false identity, purchases not made during the contest period, etc.). This individual may be brought to the attention of the appropriate legal authorities.

The register of participants may be verified by the contest administrator at any time. Any entries that are incomplete, fraudulent, submitted after the deadline, which include incorrect information or are otherwise non-compliant will be automatically rejected and will not be eligible for entry or a prize. The Contest Organizer cannot be responsible for non-compliant entries.

# Participant's identity

If there is any dispute regarding a participant's identity, the entry will be considered to have been submitted by the signatory of the notarized deed.

### PRIZES

## A total of three (3) prizes are available, with a total value of twenty thousand dollars (\$20,000).

The winner will be able to select his or her trip package (destination(s), activities, accommodation, meals included or not) up to the value of the prize.

#### SECOND PRIZE: A SUN VACATION FOR 2 VALUED AT FIVE THOUSAND DOLLARS (\$5,000)

The winner will be able to select his or her trip package (destination, activities, accommodation, meals included or not) up to the value of the prize.

## THIRD PRIZE: ONE (1) TRAVEL CREDIT WORTH FIVE THOUSAND DOLLARS (\$5,000)

The winner will be able to select his or her trip package (destination, activities, accommodation, meals included or not) up to the value of the prize.

#### **Delivery of prizes**

After the drawing, when each prize has been accepted, the winner will be contacted by CLUB VOYAGES JARO, 17, rue de la Gare, Saint-Jérôme (Québec) J7Z 2B6, who will arrange the travel with each winner.

The contest administrator will verify that each winner has received his or her prize in accordance with the contest rules.

There will be a random draw from all eligible entries on August 30, 2023, at 4:00 p.m. Eastern Daylight Time, at the offices of Groupe Mathieu, 110 rue Marie-Chapleau, Blainville, (Quebec) J7C 0E9. This draw will be electronically and randomly conducted by a software program from participation numbers entered in the register of participants. The draw and awarding of prizes are supervised by the contest administrator.

Three (3) entrants will be randomly selected. The first selected entrant will win the First Prize; the second selected entrant will win the Second Prize; the third selected entrant will win the Third Prize. Three (3) additional participants will be selected in this draw, if the first selected persons do not claim their prize. The order of draw will determine the allocation of the prizes in accordance with their acceptance.

## CLAIMING AND DELIVERY OF PRIZES

- Each selected participant must answer the phone call made by Effet Boomerang within five (5) business days following the date of the draw to be considered a winner. If the selected participant is absent, a telephone message will be left, if a voice mailbox is available. If the selected participant does not respond to this call, the contest administrator will call, in the order of draw, other selected persons in the same manner as the first selected participant. This process may be repeated until a winner is selected for the corresponding prize, up to a maximum of thirty (30) days following the date of the initial draw.

If selected contestants accept their prize, a Declaration and Release Form (the **"Declaration Form"**) will be emailed to them, and all selected entrants will have seven (7) calendar days to return the completed Declaration Form to the Contest Administrator to finalize the prize claim process.
- 3. Correctly answer a mathematical skill-testing question that will be included on the Declaration and Release Form issued by the contest organizers.

If any of the above conditions are not met, or any other conditions specified in these rules are not fulfilled, the selected contestant's entry will be forfeited and, if time permits, a new entry for that prize will be selected in accordance with these rules, until such time as a contestant is selected and declared a winner.

#### Modification, Suspension or Early Termination of the Contest

The Contest Administrator reserves the right, at its sole discretion, to cancel, terminate, modify or suspend this Contest, in whole or in part, in the event of any incident, error or human intervention that may corrupt or affect the administration, security, fairness or operation of the Contest as specified in these Contest Rules, and subject to approval by the Régie des alcools, des courses et des jeux du Québec, if required. Should participation in the Contest be terminated in whole or in part prior to the termination date set out in these Contest Rules, the Contest Administrator will randomly select winners from the entries duly registered during the Contest Period or, if applicable, up to the date of the termination event.

#### Inability to act - labour dispute

The Contest Organizer and the Contest Administrator will not be held liable in any way if their inability to act is caused by an incident or situation beyond their control or by a strike, lockout or other labour dispute in their establishment, or in the establishments of the organizations or companies that provide services for this contest.

## Authorization
